

**Terms and Conditions for Inclusive Rates
Bahrain**



Currency:	Bahraini Dinar - BHD Other currencies accepted in Bahrain are as follows: USD, GBP, EUR, AED, KWD and Saudi Riyals.						
Sales Tax:	Not Applicable.						
Airport Tax:	Not Applicable.						
Mileage:	Limited Mileage of 150 KM per day. Additional KM charged at BHD 0.05 - 0.55 depending on car group.						
Road Fund/Licence Fee:	Not Applicable.						
Additional Driver:	One additional driver permitted per rental at a charge of BHD 3.50 per day - all car groups.						
Driver requirements:	Drivers must be 25 yrs for categories: ECMR. Drivers must be 30 yrs for all other car groups. Valid photo driving licences, free of all endorsements and penalties. In addition an international drivers permit is required. International drivers permits are accepted at the discretion of the operator.						
Young Driver Surcharge:	Not applicable.						
Payment Policy:	All major credit cards are accepted: Diners, American Express, Visa, Eurocard and Master Card. Vouchers are accepted. No cash payments accepted. National charge cards and Eurocheques are not acceptable. Travellers cheques are acceptable in GBP, USD and GCC currency.						
Domestic One Way:	Free of charge provided the rental is for a minimum of 24 hours. The intention to one-way drop must be stated at the commencement of rental.						
Refuelling:	The vehicle is supplied with a full tank of fuel. Return full or refuelling charges will apply at the prevailing pump price as determined by National. A surcharge 10% will apply. Renter can purchase a full tank of fuel at local rates at the start of the rental. Fuel is approx. BHD 0.15 per litre (subject to change).						
Delivery and Collection:	Delivery and/or collection is free of charge during office hours.						
Out of Hours:	Delivery and Collection out of office hours is available on request only. Charges will be confirmed at time of reservation.						
Cross Border Policy:	It is not permitted to cross the Bahrain border.						
Third Party Liability:1 Primary	Maximum liability for third parties: Combined amount for death, bodily injury, disability and property: BHD500,000 Required by laws of country and included in the rates.						
CDW:	Collision Damage Waiver is included in the rental rate. Deductible EUR 100 - 500 depending on car						
TP:	Theft Protection is included in CDW and covers theft and malicious acts.						
SuperCDW optional:	Super Collision Damage Waiver reduces the deductible/excess on CDW. EUR 3 - 6 per day. Deductible EUR 50 - 250 depending on car group.						
PAI, Included:	PAI Is included in the rental rates. Under Third Party Liability policy the coverage is BHD100 per incident for medical expenses.

Renters should also (secondly) call National Car Rental's Emergency number in order that they may assist at the accident scene. Failure to implement the above infringes Bahrain's legal system. A replacement car will provided if necessary.
