<b>Currency:</b>	Euro - EUR €
<b>Sales Tax:</b>	21%
<b>Airport Tax:</b>	17% with a minimum charge of EUR 30 excluding tax, at Brussels Airport.
<b>Environmental Surcharge:</b>	Included in the rental rates.
<b>Mileage:</b>	Mileage is capped at 150KM per day. Additional KM's are charged at EUR 0.10 - 0.17 per KM depending on car group.
<b>Road Fund/Licence Fee:</b>	Not applicable.
<b>Additional Driver:</b>	EUR 4 per day. Must be a minimum age of 25, if under 25 a surcharge of EUR 10 per day will be made.
<b>Driver requirements:</b>	Minimum rental age 21 for categories: MBMN, ECMR, CCMR, CWMR ,CCAR. Minimum age is 25 for categories IDMR & above. Full driving license must be held for a minimum of one year. Non-Roman script licences require an International drivers permit from their country of residence. Maximum rental age is 75 years.
<b>Young Driver Surcharge:</b>	Drivers under 25 years will be charged EUR 6 per day.
<b>Payment Policy:</b>	All major credit cards are accepted: Diners, American Express, Visa, Eurocard and Master Card. National charge cards and vouchers are accepted. No cash payments accepted.
<b>Domestic One Way:</b>	Permitted for all cars in Belgium except the FDMR-FDAR-FWMR-LDAR-FVMR car groups. One way rentals must be pre-booked in advance.
<b>Refuelling:</b>	The vehicle is supplied with a full tank of fuel. Return full or refuelling charges will apply at the prevailing pump price as determined by National.
<b>Delivery and Collection:</b>	Up to 30 kms is charged at EUR 15 each way, over 30 kms is EUR 25 each way.
<b>Out of Hours:</b>	There is a drop box at the location for vehicles to be returned out of hours.
<b>Cross Border Policy:</b>	Vehicles may NOT be driven into: Albania, Belarus, Bosnia-Herzegovina, Bulgaria, Croatia, Macedonia, Malta, Czech Republic, Estonia, Hungary, Iceland, Lithuania, Serbia & Montenegro, Latvia, Poland, Romania, Russia, Slovak Republic, Slovenia, Turkey, Ukraine, Cyprus, Ireland, Russia.
<b>Third Party Liability:1 Primary</b>	Maximum liability for third parties: Unlimited coverage for death, disability and property damage. Required by laws of country and included in all rates.
<b>CDW:</b>	Collision Damage Waiver is included in the rental rate. Deductible EUR 500 - 1,000 depending on car
<b>TP:</b>	Theft Protection is included in the rental rates. Deductible EUR 500 - 1,000 depending on car group.
<b>MC 1, optional:</b>	Master Cover- includes CDW Super Cover, Theft Protection and PAI. MC1 reduces the deductible amounts of CDW & Theft protection. EUR 25 - 39 per day depending on car group. Deductible EUR 185 for all car groups.
<b>PAEC, optional:</b>	Personal Accident & Effects cover, provides limited cover of death, disability and medical expenses EUR 5.95 per day.
<b>PLI, mandatory:</b>	PLI - Primary Liability Insurance - this insurance is included in the vehicle rental rate. This does not cover the vehicle or the passengers for the rental.
<b>SC1, optional:</b>	Supercover reduces the deductible amounts to EUR 185, cost EUR 6 per day for all vehicle groups.
<b>Special Equipment:</b>	Child/Infant Seat (CSI) EUR 5 Per day Deposit EUR 100 required Baby Seat (CSB) EUR 5 Per day Deposit EUR 100 required All children under 6 years of age must travel in a child seat. All special equipment is on freesale.
