Currency:	Euro - EUR €	
Sales Tax:	19.60%	
Premium Location Charge (Airports & Railway stations)	EUR 26.76 per rental excluding tax (32 including tax)	
Corsica High Season Surcharge:	Euro 6.69 per day excluding tax (EUR 8 including tax) on all rentals from all Corsica locations.	
Winter Tyre Fee:	Winter Equipped Vehicle - From EUR 19.23 to EUR 96.15 per day excluding tax (depending on rental duration). On request only, available at some locations and for car groups CDMR, CCMR, IDMR, SDMR, NVMR, FDMR and FVMR from 01 Dec - 30 Apr.	
Mileage:	Limited mileage of 300 KM per day up to 29 days and 130 KM per day for rentals longer than 30+ days. Additional KM are charged EUR 0.16 - 0.40 excluding tax per KM depending on car group.	
Road Fund/Licence Fee:	Euro 2.26 per day including vat. Maximum charge is 4 days.	
Additional Driver:	EUR 23.24 per rental, excluding tax. In Corsica: Additional drivers fee is Euro 20.07 per rental, excluding tax.	
Driver requirements:	Minimum rental age is 21 years for car groups M-A-B-W-H-X-D-O2-Y-J-R-Z. Minimum rental age is 23 years for car groups E-L-O-N-S-K. Minimum rental age is 25 years for car groups F-P-G-T-V. Full driving licence valid for a minimum of 1 year is required. A further requirement is that the driver must present the following documentation: Either Identity Card or Passport, return tickets (train or flight) and a telephone number with a local contact. This number must not however be for a mobile phone.	
Young Driver Surcharge:	Drivers between 21 & 25 are charged an extra Euro 22.00 per day including tax, with a maximum charge of 10 days. There is no Maximum age rental.	
Payment Policy:	All major Credit cards are accepted. Debit cards, such as Visa Delta or Switch, are not accepted. Traveller cheques and Eurocheques are also not accepted. When the customer picks up the car they will be charged the full rental value if not prepaid (this includes the refuelling deposit) or Euro 1 credit check if prepaid. Cash payment is not permitted. For non prepaid car groups F-FFAR, P-LCAR, V-STMTR, the customer must provide two credit cards (but not the same issuer) at time of pick-up. Both credit cards must be in the same name (first name & surname) of the main driver. Minimum authorization is 1525 eur per card.	
Domestic One Way:	Euro 75 per rental VAT included on all public products for all normal car groups regardless of number of days. For Tour products the one way charge is free for 3 days plus (Euro 75 per rental VAT included for 1, 2 days). For STMTR & SVMR, there is a charge of EUR 230 vat included (paid locally) and for IFMR & FFAR there is a charge of EUR 450 vat included (paid locally) - these charges apply to Tour and Public Products regardless of the number of rental days. Domestic one ways between two locations in the same city area are free of charge. The following car groups FFAR, IFMR, FVMR, STMTR, SVMR are not available Domestic One Ways. If these cars are dropped off at a different location to pickup then a penalty will apply locally up to the cost of between 230 & 450 Euro including tax. One-ways between the French Mainland and the island of Corsica are not permitted. International One Ways - please consult the International One Way Policy (IOWP). These groups are not allowed for International One Way rentals IFMR, SVMR, CTAR, EXAR, STMTR and FFAR. In Corsica: One-way rentals are permitted on all products for all cars in France Corsica regardless of number of rental days at a cost of EUR 75.00, incl VAT. There is a local charge of EUR 230.00 incl VAT for FFAR, FVMR, STMTR, SVMR, CTAR, EXAR, STMTR and FFAR.	
Refuelling:	The vehicle is supplied with a full tank of fuel. Return full or refuelling charges will apply as follows: EUR 1.92 per litre including VAT for petrol and EUR 2.08 per litre including VAT for diesel.	
Delivery and Collection:	0-5 kms - EUR 15. 5-15 kms - EUR 30. Above 15 kms - On request. All the above is excluding tax. On request - charges will be advised at time of booking. There is a drop off grace period of 29 minutes. After this time any delay will be charged @ 1 full days rental rate. PLEASE NOTE (FOR PICK UPS): The 3 counters are: 1. Terminal 1, arrival hall, gate 28, in front of the baggage delivery 2. Terminal 2 ABCD, arrival hall between 2A and 2C or 2B and 2D, at shop level, in front of the Post Office and the pharmacy. 3. Terminal 2 EF, arrival hall, area 6.	
Out of Hours:	Available on request.	
Cross Border Policy:	Vehicles are permitted entry into: Austria, Belgium, Denmark, Finland, Germany, Netherlands, Italy, Liechtenstein, Luxembourg, Monaco, Norway, Portugal, Spain, Sweden, Switzerland, United Kingdom, (Corsica, Sardinia, Balearic as long as car is returned to the European mainland). There is no charge. Vehicles are NOT permitted to drive into: Albania, Belarus, Bosnia-Herzegovina, Bulgaria, Croatia, Czech Republic, Estonia, Greece - Hungary, Ireland, Latvia, Lithuania, Macedonia, Montenegro, Poland, Romania, Russia, Serbia, Slovak Republic, Slovenia, Turkey, Ukraine. Please be advised that some areas in Germany will require the vehicle to have an Emissions Sticker. Without this sticker, the driver of the vehicle will be fined up to EUR 40.00. Please refer to Germany's Surcharge section of the T&Cs for further info.	
Third Party Liability:1 Primary	Maximum liability for third parties: Unlimited coverage provided for death, disability and property damage. Required by laws of country and included in all rates.	
CDW, optional:	Collision Damage Waiver is included in the rental rate. Deductible EUR 418.06 - 1421.40 depending on car group.	
TP, optional:	Theft Protection is included in the rental rates. Deductible EUR 585.28 - 1923.08 depending on car group.	
Super CDW	Super Collision Damage Waiver, reduces the deductible amount to zero. This can only be purchased if ordinary Collision Damage Waiver has been purchased first. EUR 5.10 excluding tax per day. In Corsica, this option is available only at Figari and Porto-Vecchio locations.	
PAI:	Personal Accident Insurance, provides limited cover for death, disability and medical expenses EUR 4.42 excluding tax per day.	
Super PAI optional:	Super Personal Accident Insurance EUR 2.51 excluding tax per day (if PAI is already subscribed). Super Personal Accident Insurance EUR 6.27 excluding tax per day. Personal effects are covered by this insurance.	
Special Equipment:	Child/Infant seat (CSI) EUR 25.08 per rental excluding tax (0 - 9 months/under 9 kilos) Booster seat (CSB) EUR 22.57 per rental excluding tax (up to 10 years old) - Freesale Snow Chains (SNT) = Euro 33.44 per rental excluding VAT. On request, only available for car groups A (MCMN), B (ECMR), C (CCMR), H (VMR), D (ICMR), Y (SCMR), L (CWMR), S (FVMR). Not allowed for one way rentals. Snow Chains (SNO) = Euro 142.14 per rental excluding VAT. On request, only available for car groups F (FFAR) & G (IFMR). Not allowed for one way rentals. Ski Rack (SR) = Euro 54.34 per rental excluding VAT. On request, only available for car groups A (MCMN), B (ECMR), C (CCMR), H (VMR), D (ICMR), Y (SCMR), L (CWMR), S (FVMR). Not allowed for one way rentals. Winter Equipped Vehicle (WIN) =Euro 22.58 daily excluding VAT up to a maximum of Euro 112.88 excluding VAT. On request, only available for C (CCMR), H (VMR), D (ICMR), Y (SCMR). On request only, available at some locations and for car groups EBMM, EDMR, CDMR, IDMR, FDMR, NVMR, FVMR, SDMR, ECMR and CCMR. All special equipment is available from 1st November 2006 until 30th April 2007. Snow Chains are only available from 01 Nov 2006 - 30 Apr 2007 Partial Winter Equipment including Snow Chains and Ski Racks - From EUR 45.98 to EUR 58.52 per rental excluding tax. On request only, available at some locations and for car groups EBMM, EDMR, CDMR, IDMR, NVMR, FVMR, ECMR and CCMR. The Winter Equipped Vehicle includes - 4 snow/winter tyres, 1 Ski Rack (holds 2 pairs of Ski's), 1 pair of Snow Chains, 1 Ice Scraper. WIN: One-way is not allowed on any winter tyre equipped vehicle. A penalty fee of Euro 230.00 tax included is charged per rental otherwise. Winter Equipped Vehicle's & Snow Chains are only available from 01 Nov - 30 Apr	
Additional Charges:	A pre-authorization of EUR 1.00 is held on the customer's credit card at the beginning of each rental.
