Currency:	Euro - EUR €
Sales Tax:	24.50%
Airport Tax:	Airport fee at Keflavik International Airport EUR 20.08 per rental.
Mileage:	Unlimited.
Road Fund/Licence Fee:	Not Applicable.
Additional Driver:	A maximum of 2 additional drivers are permitted at a surcharge of EUR 20.08 excluding tax, per rental, per driver.
Driver requirements:	Minimum rental age is 20 years, there is no maximum age limit. The minimum age for renting categories PVMN and SVMN is 23 years and 25 years for LDAR and FVMN. A full driving licence valid for a minimum of one year is required.
Young Driver Surcharge:	Not Applicable.
Payment Policy:	All major credit cards (Amex, Visa, MasterCard and Diners), National charge card, National vouchers, Travellers cheques (EUR) Eurocheques, and cash are accepted with driver license identification and/or passport. A credit card is always required for deposits which are held on the card until the vehicle is returned.
Domestic One Way:	Domestic one way rentals between Reykjavik and Keflavik are allowed free of charge for all car groups. One ways between other locations are allowed at a cost of EUR 110.00 (Inc VAT) for all car groups. One Ways for groups H (SFMN), J (SVMN), K (PVMN), X (FXMN) and L (LDAR) are on request. Minimum rental length is one day. International one ways are not permitted.
Refuelling:	The vehicle is supplied with a full tank of fuel. Return full or refuelling charges will apply at the prevailing pump price as determined by National. A surcharge of 25% will apply in conjunction with cost of fuel.
Delivery and Collection:	Within office hours, customers can be picked up at their accommodation and brought to the office to collect the vehicle. This is free of charge within Akureyri city and Reykjavik city areas.
Out of Hours:	Outside of office hours the above service is available at a charge of EUR 42.57 excluding tax. An out of hours delivery charge is available for a fee of EUR 35 per delivery.
Cross Border Policy:	Vehicles are not permitted to be driven into other countries.
Third Party Liability:¹ Primary	Maximum liability for third parties: Maximum coverage provided for death and disability EUR 7,058,882. Maximum coverage for property damage EUR 7,705,992. Required by laws of country and included in all rates.
CDW, Optional:	Collision Damage Waiver is included in the rental rate. Deductible EUR 900 - 1,700 depending on car
TP, Optional:	Theft Protection is included in the rental rates. Deductible EUR 400 - 600 depending on car group.
Super CDW:	EUR 10 - 14 per day depending on car group.
PAI, mandatory:	Personal Accident Insurance is included in the rate by Iceland law.
Special Equipment	Special equipment is available on all rentals, including one ways, on a request basis with 24 advance notice required. Infant seats (under 2 yrs, 10-15 kg) and child/toddler seats (15-30 kg) are available at EUR 7 per day up to a charge of maximum EUR 47 per rental. Booster seats (6 - 10 yrs, 30kg and over) are free of charge. Luggage racks are available for vehicle groups SVMN and PVMN, and are free of charge. Ski racks are available for all groups except FVMN, SVMN, PVMN and FXMN, for a fee of EUR 7 per day, to a maximum EUR 47 per rental. Snow tyres /chains are available at Reykjavik DT Station and Akureyri DT Station from October - April free of charge. Trailers are available for Jeeps for a fee of EUR 30 per day.
Roadside Assistance:	A 24-hour emergency phone number is provided in rental documents. Mechanics from Akureyri and Reykjavik can be sent, or customers will be referred to a local garage. A replacement car will be provided if necessary.
