

Terms and Conditions for Inclusive Rates



Italy

Currency:	Euro - EUR €
Sales Tax:	20%
Airport Tax:	Airport surcharge is 16% for all airport location except Cagliari Airport which is 9%.
Premium Location Charge:	Premium Location charge is 16% + tax for all airport locations (except for Cagliari Elmas Airport CAGT1/01 where the charge is 9% + tax) and 8% + tax for all Railway locations. Premium Location fees surcharges applies on all charges, excluding fuel. Vehicle licence fee / Road fund tax is Euro 1.43 per day + tax, with a maximum charge 18 days = EUR 25.74 + tax. Contract Mandated Charge: A handling fee of EUR 1.60 + VAT per rental is applicable to cover administrative & postage expenses, which applies to all rentals.
Mileage:	Mileage capped at 100km per day, with a maximum of 150 extra km charge per day. 30 day plus rentals are capped at 3,000km. Additional km are charged at EUR 0.06-0.24 depending on car group.
Road Fund/Licence Fee:	EUR 1.43 per day, charged for a maximum of 18 days (EUR 25.74).
Additional Driver:	EUR 4.17 per day, EUR 20.50 per week, EUR 41.00 per month (All amounts subject to 20% VAT)
Driver requirements:	Minimum rental age is 19 years for all groups except: FDMR, FVMR, IDMR, SDMR, IWMR, FWAR and PVMR where the minimum rental age is 25 years. Maximum age is 75 years. An original and valid driving licence must be presented at the start of the rental. It must be readable and unbroken. The licence must have been held for at least one year. Military driving licences are not allowed. International driving licences are required for renters who present a non-EU driving licence. International Driving licences are only valid outside the country of origin and when presented along with the original driving licence.
Young Driver Surcharge:	Drivers between the age of 19-20 years a surcharge of EUR 10.85 per day will apply. Drivers between the age of 21-23 years a surcharge of EUR 5.16 per day will apply.
Payment Policy:	No Cash payments allowed. All major Credit Cards accepted (Visa, Diners, MasterCard, Amex). National Charge Cards and National Vouchers are also accepted. For a car with an engine size 1.9 & over, customer must show 2 x credit cards or Business credit card or American Express Gold or American Express / Diners which has been issued for at least 2 years. The deposit held on the customers credit card amounts to the estimated total rental charge plus 50% of theft and collision deductibles. A credit card is always required for deposits which is held on the credit card until the car is returned.
Domestic One Way:	Domestic One-way rentals are permitted within Italy, and cost as follows:- Within Italian Mainland to Mainland / Sicily to Sicily / Sardinia to Sardinia : Euro 40.00 per rental - plus VAT From Italian Mainland to Sicily & vice versa: Euro 53.00 per rental - plus VAT Intra-city one ways are free of charge. Domestic One Ways From Italian Mainland or Sicily to Sardinia & vice versa is no longer allowed for all car groups. It is allowed just within Sardinia and the cost remains the same. Euro 40.00 per rental - plus vat. Groups H, J, M & Y may only be used for Domestic one ways between locations from which they are available and these groups cannot be used for International one-ways. Group Y (FWAR) is available for both pick-up and drop-off only in: Milan Linate Apt, Milan Malpensa Apt, Venice Apt, Florence Finguerria, Florence Apt, Roma Ciampino Apt, Roma Fiumicino Apt, Rome Stazione Termini, Rome Via Po, Naples Apt, Catania Apt (Sicily) and Palermo Apt (Sicily) locations. For Mainland & Sicily, group H (PCAR) is available for both pick-up and drop-off only in: Milan Stazione, Milan Linate Apt, Milan Malpensa Apt, Venice Apt, Venice Mestre, Pisa Apt, Florence Apt, Florence Citta, Rome Ciampino Apt, Roma Fiumicino Apt, Rome Via Po, Rome Termini, Naples Apt, Naples Stazione, Catania Apt (Sicily), Palermo Apt (Sicily), Verona Apt, Verona Stazione, Turin Apt, Genoa Apt, Bergamo Apt, Bologna Apt, Lamezia Apt, Bari Apt, Bolzano, Brescia Apt, Brindisi Apt, Forli Apt, R.Calabria Apt, Treviso Apt & Trieste Apt.
Refuelling:	The vehicle is supplied with a full tank of fuel. Return full or refuelling charges will apply at the prevailing pump price as determined by National. A surcharge of EUR 12.92 will apply in conjunction with the cost of the missing fuel. Subject to 20% VAT.
Delivery and Collection:	Within renting office city limits - EUR 15.00. Outside of city limits a charge of EUR 0.86 per km with a minimum charge of EUR 15.00. (All amounts subject to 20% VAT)
Out of Hours:	Out of hours pick up and drop off - if an employee is needed, the charge will be Euro 25.82 per rental. Pick up will be at an airport agency, flight details must be supplied
Cross Border Policy:	Vehicles are allowed to cross the borders of the following countries: Austria, Belgium, Denmark, Finland, France, Germany, Italy, Luxembourg, Norway, Netherlands, Portugal, United Kingdom, Spain, Sweden and Switzerland.
Third Party Liability:-1 Primary:	Maximum liability for third parties: Maximum coverage provided for death disability and property damage: EUR 5,164,000 Required by laws of country and included in all rates.
CDW, mandatory:	Collision Damage Waiver is mandatory and is included in the rental rate. An additional non-waivable excess (NWE) for rentals starting in Puglia and Campania regions will be charged at EUR 100 - 200 depending on car group. Even if SKO is purchased, this additional NWE will be applicable for rentals in those regions regardless. The deductibles are EUR 800 - EUR 1,300 depending on car group.
TP, mandatory:	Theft Protection is mandatory and included in the rental rates. Deductible EUR 1,600-2,100 depending on car group. An additional non-waivable excess (NWE) for rentals starting in Puglia and Campania regions will be charged at EUR 200 - 400 depending on car group. Even if STP is purchased, this additional NWE will be applicable for rentals in those regions regardless.
Super TP, optional:	Super Theft Protection allows to totally eliminate theft excess payable on ordinary Theft Protection. EUR 7.50 - 8.00 per day and EUR 45.00 - 48.00 per week depending on car group. Excluding rentals that commence from Puglia and Campania regions - refer to TP section above.
PTI, optional:	Personal Travel Insurance - Covers luggage stolen or damaged in a collision. EUR 6.67 per day.
SKO, optional:	Superkasko reduces the damage deductible to zero. EUR 10.50 - 11.50 per day and EUR 63.00 - 69.00 per week depending on car group. Excluding rentals that commence from Puglia and Campania regions - refer to CDW section above.
STK, optional:	STK includes both SKO (superkasko) and STP (super theft). STK reduces the excess to zero except for locations in: Bari, Brindisi, Caserta, Campobasso-Ripalimosani, Foggia, Isernia, Lecce, Naples, Pozzuoli, Salerno Taranto and Termoli where the deductibles are only reduced as for SKO and STP. Cost per day between : EUR 16.00 - EUR 17.50 Cost per week: EUR 96 - EUR 105 Cost per month: EUR 240 - EUR 262.50
PAL, optional:	Personal Accident Insurance - EUR 5.21 per day.
Special Equipment:	Child/Infant seat CSI = Euro 35.83 per rental. Child/Toddler seat CST = Euro 35.83 per rental. Booster Cushion BST = Euro 35.83 per rental. Snow chains SNO = Euro 29.17 per rental (available for all car groups except FVMR/PVMR) (available all year round) Ski rack SKV = Euro 30.83 per rental (available for all car groups except FVMR/PVMR). All Special Equipment is on freestyle and is subject to 20% tax. All cars will be equipped with a reflective jacket which must be worn in an emergency else a fine will be levied. There is no extra charge for the use of this but if not returned then 18 Euros will be charged. Also available is the GPS Navigation Device at a cost of Euro 6.40 per day + VAT. GPS Navigation cannot be confirmed at the time of the reservation but it can be requested at pick-up time and one way is not available.
