

**Terms and Conditions for Inclusive Rates
Kuwait**

| Currency: | Kuwait, Dinar KWD |
| Sales Tax: | 0% |
| Airport Tax: | Not applicable. |
| Mileage: | Limited to 150 kms per day. |
| Premium Location: | KWD 0.50 per rental at Kuwait airport. International Drivers fee - KWD 2.00 per rental. |
| Road Fund/Licence Fee: | Not applicable. |
| Additional Driver: | A maximum of 2 additional drivers are permitted at a surcharge of KWD 2 per day, per driver. |
| Driver requirements: | Minimum rental age is 21 years. Maximum rental age is 60 years. If GCC citizen then license of resident country accepted. All other International licenses subject to a fixed charge agreement to purchase drivers license insurance. International driving licence should be valid and presented during contract opening. |
| Young Driver Surcharge: | Not applicable. |
| Payment Policy: | All major credit cards are accepted: Diners, American Express, Visa, Eurocard and Master Card. National charge cards and vouchers are accepted. No cash payments accepted. A credit card is required for the deposit. A deposit for the full amount of the rental and excess is held against a credit card until the vehicle is returned. |
| Domestic One Way: | Domestic one ways are allowed and free of charge between National locations. |
| Refuelling: | The vehicle is supplied with a full tank of fuel. Return full or refuelling charges will apply at the prevailing pump price as determined by National. |
| Delivery and Collection: | No charge within Kuwait City. Between 10 - 20 kms will be charged at KWD 5. Between 21 - 30 kms will be charged at KWD 10. Over 30 kms will be charged at KWD 20. Out of hours delivery and collection charges are in addition to the standard delivery and collection charges. |
| Out of Hours: | Between 0 - 20 kms will be charged at KWD 5. Between 21 - 30 kms will be charged at KWD 10. Over 30 kms will be charged at KWD 20. |
| Cross Border Policy: | Renters will require a letter of authority to cross the Kuwait border into Iraq. This will be issued by the company or guarantor to acknowledge the journey. In addition the renter requires a current and authorised Visa for the country, a signed traffic violation form and a signed indemnity letter from payee or customer. 24 hours notice is required. The following are required to cross border: 1: Extra Insurance 2. Full rental charges will be taken as deposit. 3. Minimum one month rental period is required. |
| Third Party Liability:1 Primary | Maximum liability for third parties: Limited amount for death, bodily injury, disability and property. Limits are subject to Kuwait law. Required by laws of country and included in the rates. |
| CDW, optional: | Collision Damage Waiver is included in the rental rate. The deductable is zero. |

| Special Equipment: | CSI - Child/Infant Seat KWD 1 per day, maximum KWD 20 - on request - 48 hours advanced notice required. |
| Roadside Assistance: | A replacement vehicle will be supplied in the case of breakdown. In case of accidents 24 hour emergency number provided on rental agreement and located within car. Drivers must first call the police to ensure report is gained at scene of accident. National emergency number should be called to aid assistance during the police incident. |
