



**Terms and Conditions for Inclusive Rates  
Malta**



<b>Currency:</b>	Euro - EUR €
<b>Sales Tax:</b>	18%
<b>Airport Tax:</b>	EUR 9 per rental.
<b>Mileage:</b>	Unlimited.
<b>Road Fund/Licence Fee:</b>	Not applicable.
<b>Additional Driver:</b>	EUR 3.50 + Tax per day.
<b>Driver requirements:</b>	Minimum rental age is 21 years for all groups except SVMR which is 25 years. There is no upper age limit, but if the driver is over 70 years they need a doctors certificate confirming they are fit to drive.
<b>Young Driver Surcharge:</b>	Young drivers 21-24 years will be charged Euro 5.00 + tax per day
<b>Payment Policy:</b>	Cash rentals are NOT permitted (FOR EITHER BRAND). All major credit cards accepted. National charge card, National vouchers, Eurocheques, Travellers cheques in USD & GBP. Deposit is held against a credit card until the return of the vehicle. A charge of Euro 250 + tax will be taken as a deposit (this deposit is over and above rental charges)
<b>Domestic One Way:</b>	Not applicable.
<b>Refuelling:</b>	Vehicles will be supplied with half a tank of fuel. Vehicles should be returned empty. No refunds will be given if the vehicle is returned with fuel in the tank at the end of the rental.
<b>Delivery and Collection:</b>	Available from all locations at a charge of EUR 8 + Tax each way.
<b>Out of Hours:</b>	Out of hours rentals are only serviced at airports at a charge of EUR 9 + Tax
<b>Cross Border Policy:</b>	Vehicles are not permitted to leave Malta, except to the Island of Gozo.
<b>Third Party Liability:1 Primary</b>	Maximum liability for third parties: Unlimited coverage for death and disability, maximum liability for property damage: ML 100,000. Required by laws of country and included in all rates.
<b>CDW, optional:</b>	Collision Damage Waiver is included in the rental rate. Deductible ML 100 applies.
<b>TP, optional:</b>	Theft Protection is included in the rental rates. Deductible ML 100 applies.
<b>PAI, optional:</b>	Personal Accident Insurance ML 1 per day.
<b>Special Equipment:</b>	Child/Toddler seat CST = Euro 3.50 + tax per day Suitable for 2 to 4 year olds. Infant seats are not available for Jeeps and minibuses. Luggage rack LUG = Euro 3.50 + tax per day Only valid for car group K=CWMR <small>All equipment is on request, with advanced 7 days notice required.</small>
