

**Terms and Conditions for Inclusive Rates
Mauritius**



Currency:	Mauritius Rupee - MUR
Sales Tax:	15%
Airport Tax:	MUR 300.00 + tax per rental.
Mileage:	Unlimited.
Road Fund/Licence Fee:	Not Applicable.
Additional Driver:	MUR 300.00 plus tax per rental. Maximum of four additional drivers allowed per rental.
Driver requirements:	Minimum rental age is: 21 years for car groups: MDMR, CDMR, EDMR, ECMR, CCMR & 25 years for car groups: ICMR, PDMR, PFAR, PFMR, MTAR, MTMR & SDMR. There is no maximum age. Driver must present a valid driving licence at time of rental. Minimum licence requirement is one year for car groups: MDMR, CDMR, EDMR, ECMR, CCMR, ICMR & a minimum of two years for all other car groups. An international driving permit is required, but is not mandatory.
Young Driver Surcharge:	Not Applicable.
Payment Policy:	Acceptable methods of payment are: Visa, Diners, Mastercard, Amex, National Charge Cards & National Vouchers. Cash, Travellers Cheques & Eurocheques are not accepted. A deposit of 275 EURO + 20% of Estimated Rental is held on the credit card until the car is returned.
Domestic One Way:	One way rentals are permitted between all locations and for all car groups provided the rental is for at least 24 hours. The charge for one-ways is MUR 300.00 + tax. One-ways must be pre-booked. International one ways are not permitted.
Refuelling:	The vehicle is supplied with a full tank of fuel. Return full or refuelling charges will apply at the prevailing pump price as determined by National.
Delivery and Collection:	Available at the Hotels at an extra charge of MUR 125.00 + tax. Airport delivery & collection is charged at MUR 110.00 + tax. Delivery & Collection is not allowed outside of office hours.
Out of Hours:	Out of hours pick-ups and drop-offs are not allowed.
Cross Border Policy:	It is forbidden to drive on unpaved roads or to cross the sea via ferry. It is not permitted to leave
Third Party Liability:1 Primary	Maximum liability for third parties: Unlimited coverage for death. Maximum coverage for disability: MUR 100,000,000 Maximum liability for property damage: MUR 12,000,000 Required by laws of country and included in all rates.
CDW, optional:	Collision Damage Waiver is included in the rental rate. Deductible MUR 11,000 - 15,000 depending on car
TP, optional:	Theft Protection is included in the rental rates. Deductible MUR 2,500 applies.
PAI, optional:	Personal Accident Insurance MUR 150 per day.
Special Equipment:	Infant seat - CSI - (0 - 12 months - rear facing) = MUR 100.00 + tax per day. Deposit required of MUR 6,000.00. Baby Seat - CSB - (1 - 3 years) = MUR 100.00 + tax per day. Deposit required of MUR 6,000.00. Baby seats are not loaded in the system. If required, please add to the remarks. Toddler Seat - CST - (4 - 7 years) = MUR 100.00 + tax per day. Deposit required of MUR 7,000.00. All equipment is on request only. All special equipment is available for one-ways.
Roadside Assistance:	All information will be given to the client at the time of rental. In the event of breakdown/accident a replacement vehicle will be provided if necessary. In the event of an accident the driver must report to the police within 4 hours. Call the nearest National Location and a representative of the company will come to assist the driver.
