



**Terms and Conditions for Inclusive Rates  
Serbia & Montenegro's**



<b>Currency:</b>	Euro - EUR €
<b>Sales Tax:</b>	17% in Montenegro and 18% in Serbia.
<b>Airport Tax:</b>	EUR 15 per rental excluding tax.
<b>Mileage:</b>	Unlimited.
<b>Road Fund/Licence Fee:</b>	Not applicable.
<b>Additional Driver:</b>	EUR 5 per day excluding tax. Additional Driver must have a full driving licence valid for a minimum of two years.
<b>Driver requirements:</b>	Minimum rental age is 21 years. A full driving licence valid for a minimum of two years is required.
<b>Young Driver Surcharge:</b>	Not applicable.
<b>Payment Policy:</b>	Credit cards accepted are: Diners, Visa, Eurocard and Master Card. National charge cards, vouchers, travellers cheques and Eurocheques are accepted. No cash payments accepted. A credit card is always required for the deposit. For credit card payment a deposit is held of double the amount of the rental until the vehicle is returned.
<b>Domestic One Way:</b>	No charge.
<b>Refuelling:</b>	The vehicle is supplied with a full tank of fuel. Return full or refuelling charges will apply at the prevailing pump price as determined by National. Service fee will be charged at EUR 10.00 plus tax.
<b>Delivery and Collection:</b>	Free delivery and collection within 12 km of the National location. Distances further than 12 km a surcharge of EUR 1 per km, incl first 12 EUR of fuel.
<b>Out of Hours:</b>	Out of hours from 21:00 - 00:00 = EUR 20 each way in addition to the delivery and collection charges. From 00:00 - 06:00 = EUR 40 + VAT.
<b>Cross Border Policy:</b>	24hrs notice required for this country. Vehicles can be driven into : Austria, Belgium, Bosnia & Herzegovina, Bulgaria, Croatia, Czech Republic, Denmark, Estonia, Finland, France, Germany, Hungary, Italy, Latvia, Lithuania, Luxembourg, Republic of Macedonia, Netherlands, Norway, Poland, Portugal, Romania, Slovakia, Slovenia, Spain and Switzerland. Cars will not be permitted to cross into any other country. No other documents are required except car license, driver's licence, rental agreement, green card (insurance).
<b>Third Party Liability:1 Primary</b>	Maximum liability for third parties: Limited coverage of EUR 1 million for death, disability, and property damage. Required by laws of country and included in all rates.
<b>CDW, mandatory:</b>	Collision Damage Waiver is included in the rental rate. Deductible EUR 200 - 800 depending on car group.
<b>SCDW, mandatory:</b>	Super CDW is included in the rental rates. In this case the deductible is zero.
<b>TP, mandatory:</b>	Theft Protection is included in the rental rates.
<b>FTP, mandatory:</b>	Full TP is included in the rental rates. In this case the deductibles is zero.
<b>PAI, mandatory:</b>	Personal Accident Insurance EUR 1.50 - 2.50 per day depending on car group.
<b>Special Equipment:</b>	CSI - Infant Seat EUR 5 per day maximum charge EUR 30 - on request. CST - Child/Toddler seat EUR 5 per day maximum charge EUR 30 - on request. LUG - Luggage Rack - EUR 5 per day maximum charge EUR 30 - on request. SKI - Ski Rack - EUR 5 per day maximum EUR 30 - on request. SNO - Snow Tyres/Chains - EUR 5 per day maximum charge EUR 15 - on request. Winter ski racks and snow tyres / chains they are only available at Belgrade Airport, Belgrade Downtown 1. All special equipment is available for one ways and only available for car groups A - E, B - C, CCMR and C.- ICMR.
<b>Roadside Assistance:</b>	In the event of a breakdown the driver must call the location from which the vehicle was rented. A replacement car is provided if necessary. In the event of an accident the customer must immediately contact the location from which the vehicle was rented, and the nearest police station. A special report form (supplied at the time of rental with the car documents) must be filled out and sent /delivered immediately to the rental location. If necessary a replacement vehicle will be provided. Renters must cooperate with National in any subsequent investigation or procedure concerning the accident. Renters will be held responsible for all expenses if the terms of the rental-agreement are not adhered to.
