Sales Tax:	19%
Airport Tax:	EUR 50 excluding tax, per rental.
Mileage:	Limited mileage of 150 KM per day. Additional KM are charged EUR 0.10-0.17 depending on car group.
Environmental Surcharge:	Included in the rental rates.
Road Fund/Licence Fee:	Not applicable.
Additional Driver:	EUR 4 per day, minimum age 25 years.
Driver requirements:	Minimum rental age is 21 years. Maximum age 75 years. Full drivers licence valid for a minimum of 1 year is required. Non-Roman script licences require an international drivers permit from their country of residence.
Young Driver Surcharge:	Drivers between 21 - 24 years a surcharge of EUR 6 per day applies. Young drivers between 21 & 24 years can only rent the following categories: MBMN, ECMN, CCMN, CCAN & CWMN.
Payment Policy:	All major credit cards are accepted: Diners, American Express, Visa, Eurocard and Master Card. National charge cards and vouchers are accepted. No cash payments or travellers cheques are permitted. Two credit cards are required when renting the following vehicle groups: F=FDMR, FA=FDAR, FE=FWMR and HA=LDAR.
Domestic One Way:	No charge.
Refuelling:	The vehicle is supplied with a full tank of fuel. Return full or refuelling charges will apply at the prevailing pump price as determined by National.
Delivery and Collection:	Up to 30 kms is charged at EUR 15 each way, over 30 kms is EUR 25 each way.
Out of Hours:	Not available.

Third Party Liability:1 Primary	Maximum liability for third parties: EUR 2,250,000.00 combined for death, disability and property damage. Required by laws of country and included in all rates.
CDW, optional:	Collision Damage Waiver is included in the rental rate. Deductible EUR 500 applies.
TP, optional:	Theft Protection is included in the rental rates. Deductible EUR 500 applies.
