

**Terms and Conditions for Inclusive Rates
Poland**



Currency:	Euro - EUR €
Sales Tax:	22%
Airport Tax:	No charge.
Mileage:	Unlimited.
Road Fund/Licence Fee:	Not applicable.
Additional Driver:	EUR 2.30 excluding tax per day.
Driver requirements:	Minimum rental age is 21 years for categories ECMN & CCMN, for categories SDMR & CWMN the minimum age is 25. Full driving licence that has been valid for a minimum of one year is required. Non - European customers require a valid International driving permit.
Young Driver Surcharge:	Not applicable.
Payment Policy:	All major credit cards are accepted: Diners, American Express, Visa, Eurocard and Master Card. National charge cards and vouchers are accepted. No cash payments accepted
Domestic One Way:	There is a charge of Euro 50.00 for Domestic one way rentals. There is a minimum rental length of three days for all domestic one ways. International - Please consult the International One Way program (IOWP)
Refuelling:	All vehicles are supplied with a full petrol tank and the Renter must pay for the missing petrol at the end of the rental. It is the Renter's responsibility to refuel with the proper type of petrol. Refuelling charge is 1.64 EUR exc VAT per litre.
Delivery and Collection:	Free of charge to hotels in cities and towns with National locations. Delivery/collection to/from other cities within Poland EUR 0.62 including tax per KM.
Out of Hours:	A surcharge of EUR 21 including tax applies for pick-up or drop-off between 22:00 & 07:00 Hours in Warsaw, 19:00 & 08:00 in Gdansk, 17:00 - 09:00 all other locations.
Cross Border Policy:	Cars are not permitted to be driven into: Albania, Belarus, Bosnia-Herzegovina, Croatia, Estonia, Greece, Latvia, Lithuania, Macedonia, Montenegro, Turkey, Romania, Serbia, Bulgaria and Ukraine. For other countries a special insurance (Green Card) should be taken at a cost of EUR 12.27-26.08, depending on engine size and length of rental. A kilometer limitation is also applied for travel outside Poland of 220 kilometers per day. Each additional km will be charged as follows: ECMN = EUR 0.20 + tax, ECMR = 0.20 + tax, CCMR = 0.25 + tax, CWMR = 0,30 + tax, IDMR = 0.35 + tax, ICAR=0,35 + tax, SVMR = 0,95 + tax, paid locally .
Third Party Liability:1 Primary	Maximum liability for third parties: Combined amount for death , disability and property damage: EUR 600,000 Required by laws of country and included in all rates.
CDW, optional:	Collision Damage Waiver is included in the rental rate. Deductible EUR 210 - 490 depending on car
TP, optional:	Theft Protection is included in CDW.
SCDW, optional:	Super Collision Damage Waiver, reduces the deductible to zero. Cost per day EUR 8 - 10, depending on car group.
Special Equipment:	Child/Infant seat (CSI) - EUR 2.80 per day - EUR 28 per rental - freesale. Child seats are suitable for up to 11 years old children. Mobile phones are not available to rent. Winter Tyres are available free of charge with every rental. GPS is available at all locations and for all cars at a cost of EUR 7.00 per day (max charge or EUR 70.00 per rental) - Deposit of EUR 200.00 is required - 24 hours notice required (freesale) and its not available for one ways. This country does not provide reflective jackets and is not required by law to do so.
Roadside Assistance:	Emergency telephone numbers in case accident or breakdown: Call the nearest National location. If out of hours call using the locations mobile numbers. These numbers will be supplied at the point of rental.
