

**Terms and Conditions for Inclusive Rates
South Africa**



Currency:	South African Rand - ZAR
Sales Tax:	14%
Apt Tax:	9% excluding tax
Tourism Tax	1% excluding tax
Mileage:	Limited to 200 KM per day, additional KM will be charged ZAR 0.93 - 6.08 depending on car group.
Road Fund/Licence Fee:	Not Applicable.
Contract Fee:	ZAR 30.70 excluding tax (applies to all rentals). A claim handling fee of ZAR 394.74 + tax applies in the event of damage or loss (paid locally).
Additional Driver:	A fee of ZAR 114.04 excluding tax per additional driver, per rental. There is no maximum to the number of additional drivers allowed per rental. Same conditions apply as per the main driver.
Driver requirements:	Minimum age is 18 years for all cars & there is no maximum age. ZAR 105.26 excluding tax per driver per day. Driver/s must have obtained their license at least two years prior to renting a vehicle. An International Drivers Permit is mandatory for foreign customers.
Young Driver Surcharge:	ZAR 105.26 excluding tax per driver per day. (18-23 years)
Payment Policy:	Acceptable methods of payment are: MasterCard, Visa, Amex, Diners, National Charge Cards, National Vouchers, Travellers Cheques & Eurocheques. A deposit of 20% of the estimated rental charges plus ZAR 2968.61 excluding tax is required. The deposit is held on the credit card until the car is returned. Cash is ONLY accepted to pay the deposit.
Domestic One Way:	Domestic one ways - charges vary between R219.30 excluding tax and R543.90 excluding tax, depending on the distance. The charge will be confirmed at time of reservation. Some domestic one ways are free of charge. Please see separate one way grid for details. One way are available for all cars and must be pre-booked. International One ways are not allowed.
Refuelling:	The vehicle will be re-fuelled upon return. Any required fuel will be charged to the renters account.
Delivery and Collection:	During office Hours: Only available for some locations. ZAR 131.58 excluding tax up to 25Kms. The charge for each additional KM is ZAR 4.83 excluding tax. Out of Hours: Not Available.
Out of Hours:	Not Available
Cross Border Policy:	Prior authorisation is required for clients wishing to cross the border of the country in which the vehicle is rented. A fee of ZAR 394.74 + tax is levied for cross border rentals. Car groups O/PDAR & H/FDAR are not allowed to cross the border. Cross border travel is allowed into the following countries: Botswana, Lesotho, Namibia, Swaziland & Mozambique. Cross border travel is NOT allowed into Angola & Zimbabwe. A non-refundable fee of ZAR 1000.00 + tax will be levied for all vehicles crossing into Mozambique & Zambia. If cross border travel is required, this must be stated at time of reservation.
Third Party Liability:1 Primary	Maximum liability for third parties: Maximum property liability for third parties death disability: ZAR 1 million. Public liability: full cover. Required by laws of country and included in all rates.
CDW, mandatory:	Collision Damage Waiver is included in the rental rates. Deductible is ZAR 4,000 - 11,000 depending on car group. The applicable excess amount will double, should the accident/theft occur outside the borders of South Africa or Namibia.
TP, mandatory:	Theft Protection is included in the rental rates. Deductible is ZAR 4,000 - 11,000 depending on car group. The applicable excess amount will double, should the accident/theft occur outside the borders of South Africa or Namibia.
Super CDW & Super TP, optional:	Super Collision Damage Waiver and Super TP is charged at ZAR 81-284, depending on car group. Deductible ZAR 980 - 5,550 depending on car group.
PAI, optional:	Personal Accident Insurance ZAR 16 per day.
Special Equipment:	Infant Seat - CSI - (0 - 12 Months) ZAR 131.57 excluding tax per rental. Available for all cars. On Request Baby Seat - CSB - (1 - 3 years) ZAR 131.57 excluding tax per rental. Available for all cars. On Request. For Lanseria Apt (HLAT01/71), Newcastle (NCSC01/71) & Umhaya Apt (UTTT01/71) the baby seat is on freesale. Baby seat cannot be loaded in the system so please add to the remarks on the reservation). Extra Spare Tyre - ZAR 526.31 excluding tax per rental. On Request. Only available at some locations. Mobile Phone - The request for a mobile phone can be sent with the reservation (add to remarks) & South Africa will make arrangements with Vodaphone. Additional Charges:	Renters who receive traffic fines during the rental period will be charged a handling fee of ZAR 100 excluding tax per fine, plus the amount of the fine received.
