

Terms and Conditions for Inclusive Rates Slovenia	
Currency:	Euro - EUR €
Sales Tax:	20%
Airport Tax:	Not applicable
Mileage:	Unlimited.
Road Fee:	EUR 4.17 + tax per rental applicable to all rentals (paid locally).
Additional Driver:	The first additional driver is added free of charge, any other additional drivers are charged EUR 5.00 excluding tax per driver per day, with a maximum charge of EUR 25.00 excluding tax per rental. Maximum number of additional drivers is 3.
Driver requirements:	Minimum rental age is 18 years. Maximum rental age is 80 years. All valid drivers licences are accepted. International licences are accepted only accompanied by a national one. Client must also provide a valid passport and a credit card for identification purposes (for some car groups there are additional conditions – see payment policy)
Young Driver Surcharge:	Not applicable.
Payment Policy:	All major Credit cards are accepted (Visa, Amex, Diners, MasterCard). For groups M=LDAR, H=XDAR, and N=XFAR 2 x credit cards are required. National Charge Cards, National Vouchers and Karanta Cards also accepted. (Karanta Card is a payment used locally). For cash payments: a credit card and necessary documents have to be presented when picking up the car, then upon return, settlement can be paid with cash. A deposit is required, which must be paid on a credit card & will be held on the credit card until the car is returned. For credit card & cash rentals the deposit taken will be the total rental cost, fuel deposit and excess deposit when applicable. If CDW is declined, the deposit taken will be the total car value plus the total rental cost, fuel deposit and excess deposit when applicable.
Domestic One Way:	Permitted between National/Alamo offices within Slovenia at no charge for rentals 3 days or more. For rentals from one to two days an extra charge of EUR 15.00 + tax will apply. Minimum length of rental is 1 day and available for all cars. International - please consult the International one way program (IOWP) - charges will apply. All international one way rentals must be minimum 3 days. All one ways must be pre-booked.
Refuelling:	Car is supplied with a full tank, and must be returned full unless specifically instructed by the rental location staff. Refuelling charges will apply if the car is returned with less fuel than agreed.
Delivery and Collection:	During Office Hours: within city limits up to 20 km free of charge. Outside city limits (more than 20 km) there is a charge of EUR 20.00 + tax. When returning cars there is a Grace period of 59 minutes, after that time an additional day will be charged and every subsequent 24 hours. Out of Hours: Same as during office hours, plus an additional charge of EUR 20.00 + tax.
Out of Hours:	This service is provided at a surcharge of EUR 21 each way in addition to delivery and collection charges.
Cross Border Policy:	Vehicles are permitted to be driven into any foreign state except Iraq. No advance notice and no additional document required.
Third Party Liability:¹ Primary	Maximum liability for third parties: For death, disability and property damage limited coverage of EUR 1 million. Required by laws of country and included in all rates.
CDR, optional:	Collision Damage Reduction is included in the rental rate. Deductible EUR 204.52 - 511.29 depending on car group.
TP, optional:	Theft Protection is included in the rental rates. Deductible EUR 204.52 - 511.29 depending on car group.
PAI, optional:	Personal Accident Insurance is charged at EUR 1.53 per day.
Special Equipment:	Child/Infant seat CSI (0 to 1 year / 0 to 10 Kgs) = EUR 5.00 + tax per day, maximum charge of EUR 25.00 + tax per rental. On Freesale & available for all cars. Child/Toddler seat CST (1 to 6 years / 9 to 25 Kgs) = EUR 5.00 + tax per day, maximum charge of EUR 25.00 + tax per rental. On Freesale & available for all cars. Child/Booster seat BST (6 years up / 25 to 36 kgs) = EUR 5.00 + tax per day, maximum charge of EUR 25.00 + tax per rental. On Freesale & available for all cars. For all child seats, the age and weight of the child must be provided at time of reservation. All children up to the age of 12 years must be seated in a child/booster seat. Parents are fully responsible for the proper choice of the type of infant/child seat/booster seat. Magnetic Ski rack (for two pairs of ski's) SKV = EUR 5.00 + tax per day, maximum charge of EUR 25.00 + tax per rental. On Freesale. Ski racks can be fitted to all car groups except A1=MBAR. Ski equipment is not provided. Winter Equipped Vehicle - MANDATORY by law from 15th November to 15th March (includes winter tyres and winter car fluids). Mobile phones are not available. GPS Navigation GPS is available at all locations on freesale for EUR 10.00 + tax per day for car groups C=CDMR and upwards. Not allowed for international one way rentals. This country does not provide reflective jackets and is not required by law to do so.
Roadside Assistance:	Emergency assistance: all locations via telephone +386 (0)1 589 0868 round the clock 24h. A replacement car will be provided if necessary.
