<b>Spain</b>																																
<b>Currency:</b>	Euro - EUR €																															
<b>Sales Tax:</b>	16%. Canary Islands 13%.																															
<b>Airport Tax:</b>	EUR 22.50 per rental excluding tax for the first rental day plus EUR 2.10 per additional day.																															
<b>Mileage:</b>	Limited mileage of 390 KM per day. Additional KM are charged EUR 0.10-0.18 depending on car group.																															
<b>Road Fund/Licence Fee:</b>	Not applicable.																															
<b>High Season:</b>	A High Season service charge of EUR 30 will be applied for the following 2008 dates only: Easter holidays 20th-24th March/Summer Season: 1st-17th August/ Christmas: 22nd December-3rd January 2009. This applies for Mainland Spain and Balearics only.																															
<b>Railway Surcharge:</b>	EUR 5.50 excluding tax per rental.																															
<b>Service Charge:</b>	All rentals all locations: EUR 10 excluding tax.																															
<b>Additional Driver:</b>	EUR 5.75 excluding tax per day with a maximum of Euro 46 excluding tax. Maximum 3 additional drivers.																															
<b>Driver requirements:</b>	Minimum rental age for categories EBMR, EDMR, CCMR, CDMR, CDAR and IWMR is 21 years. The minimum age for category PDMR is 25 years. All other groups minimum rental age is 23 years. Full driving licence valid for a minimum of 2 years is required. Non-Roman script licences must have an International driving permit and a licence issued from country of domicile. <b>Payment Policy:</b>	All major Credit cards (VISA, AMEX, Master Card, Diners), National Charge Cards and National Vouchers are also accepted. Travellers Cheques and Eurocheques are not accepted. Cash rentals are not allowed. An international valid credit card is required and a deposit on the credit card will be held. If cards do not permit deposits, then charges will have to be made. A credit card is always required for deposits. The deposit will be the estimated rental fees which is held on the credit card until the car is returned. See																															
<b>Domestic One Way:</b>	Domestic one ways are available for cities located within the Spanish Peninsular and intra Islands (same island). Not allowed between Islands and Mainland (and vice versa) or among Islands. For the Canary Islands one ways are allowed among the locations situated into the same island. For the Balearics, one ways between locations within the same island and where the service is provided by Hiper Rent-a-Car are available, but one ways are not allowed to, from or between: Menorca Airport (MAHT01/71), Ibiza Airport (IBZT01/71) & Palma Airport (PMIT01/71). One ways are also allowed between Sunbelt and Mainland																															
<b>Refuelling:</b>	Car is supplied with a full tank, the customer must return full or cost will be Euros 11.75 excluding tax plus the price of missing fuel.
