



**Terms and Conditions for Inclusive Rates  
United Arab Emirates**



<b>Currency:</b>	Dirham - AED
<b>Sales Tax:</b>	Not applicable
<b>Airport Tax:</b>	AED 5 per rental.
<b>Mileage:</b>	Limited Mileage of 150 KM per day. Additional KM charged at AED 0.85 - 2.81 depending on car group.
<b>Road Fund/Licence Fee:</b>	Not Applicable.
<b>Additional Driver:</b>	A maximum of 1 additional driver is permitted per rental at a surcharge of AED 30 excluding tax, per day.
<b>Driver requirements:</b>	Any valid driving licence acceptable apart from those with endorsements and penalties. Drivers must be in possession of a valid drivers licence held for at least 1 year. Visitors from UK, USA, France, Japan, Belgium, Holland, Switzerland, Denmark, Germany, Italy, Sweden, Greece, Austria, Ireland, Spain, Norway, Turkey, Canada, Poland, Korea, Finland, South Africa, Australia, New Zealand & Romania are allowed to drive in the UAE with their local valid driving license. Visitors from Korea, Japan, Turkey & Greece are requested to have a translation of their licenses approved by the Council/Embassy. An international driving permit is required for visitors from any other country.
<b>Young Driver Surcharge:</b>	Not Applicable.
<b>Payment Policy:</b>	All major credit cards are accepted: Diners, American Express, Visa, Eurocard and Master Card. National charge cards and vouchers are accepted. No cash payments accepted
<b>Domestic One Way:</b>	Between all locations within the Emirates of Dubai free of charge.
<b>Refuelling:</b>	The vehicle is supplied with a full tank of fuel. Return full or refuelling charges will apply at the prevailing pump price as determined by National.
<b>Delivery and Collection:</b>	Free within the Dubai City limits.
<b>Out of Hours:</b>	Out of hours service is free of charge within the Dubai city limits.
<b>Cross Border Policy:</b>	24hrs notice required. Documentation required will be valid copy of UAE insurance plus Oman Insurance approval, drivers license and rental agreement.
<b>Third Party Liability:1 Primary</b>	Limited coverage for death, disability and property damage. Limits subject to UAE Law. Required by laws of country and included in all rates
<b>CDW mandatory:</b>	Collision Damage Waiver is included in the rental rate. Deductible AED 750 - 2,000 depending on car
<b>TP, optional:</b>	Theft Protection is included in the rental rates. AED 10 - 20 depending on car group.
<b>PAI:</b>	Personal Accident Insurance is mandatory and included in the rental rates. Provides comprehensive cover for death or bodily injury up to the amount of AED 150,000.
<b>Special Equipment:</b>	Infant Seat: AED 15 per day (up to max AED 100 per rental) - on request - 3 days advanced notice required. Child Seat: AED 15 per day (up to max AED 100 per rental) - On request - 3 days advanced notice required. Also available one way.
<b>Roadside Assistance:</b>	A replacement vehicle will be supplied in the case of breakdown. In case of accidents a 24 hour emergency number provided on rental agreement and located within car. Drivers must first call the police to ensure report is gained at scene of accident. The National location emergency number should be called to aid assistance during the police incident. Failure to call police infringes country legal system.
