LAW IN THE MUSLIM WORLD
Professor Adrien Katherine Wing
Fall 2009

This course will survey a selection of the various types of laws existing in the nearly 60 countries of the Muslim world. The subjects will include: Islamic law; unwritten customary law; civil law including constitutional, commercial, and criminal law; international human rights law, particularly women's rights, and a case study on the right to self-determination; and public international law relating to terrorism.

READINGS

The readings will consist of photocopied handouts. To keep pace with late breaking events, additional materials may be distributed throughout the course. There may be guest speakers as well.

COURSE EVALUATION

This course is not on the usual curve of the law school because of the nature of the grading.

1. There will be a take home open book final exam distributed at the end of the course. The number of days to complete the final will be mutually agreed upon by the class. The exam will count 40% of the final grade.
2. Class participation will count 10% of the final grade. It includes regular class attendance and preparation as well as active contribution to class discussion. Comments should evidence a mastery of the readings. Any one who will be absent should email my secretary.
3. Each student will do an oral and written class presentation of one day's readings. Because of the size of the class, this assignment is likely to be done in small groups. Many students do power point presentations and email the presentation. It may include: questions raised by each reading, relations of the readings to other readings and current events, issues for further study, etc. It must NOT be a mere summary of the reading. This aspect may include a role play, moot court, film clip or some other creative component. This assignment is worth 20%.
4. There will be a simulation at the end of the course. Students will do an oral presentation and submit a written component. Because of the size of the class, this assignment may be done in small groups. The simulation will count 30%.
5. Nonlaw students will be graded separately from law students. All policies and procedures relating to this course will be handled under the regulations of the College of Law.

6. Those law students desiring to do a research paper for writing credit should be sure to discuss the proposed paper with me early in the semester.

7. Any student needing exam or other accommodations to comply with the requirements for this course should contact the Associate Dean for Student Affairs Carin Crain.
