Professional Summary

My professional expertise is based on fieldwork and research conducted over more than two decades. These activities have dealt with five of the basic North American Prehistoric Cultural Areas: the Great Plains Area (all five Sub-areas), the Eastern Woodlands Area (Upper Mississippi Valley, Central Mississippi Valley, Ozark Highlands, Ohio Valley, Great Lakes and Southeastern Sub-areas), the (eastern) Great Basin Area, the Southwest Area (Anasazi Sub-area) and the Interior Plateau.

I have participated in a variety of surveys and site testing and excavations ranging in age from PaleoIndian through Historic Periods. My responsibilities as project director have included field and laboratory analysis, personnel administration, Native American consultations and other public relations. Document preparation included writing and production of numerous large and small reports, research designs, proposals, archaeological chapters in Environmental Impact Statements and 106 Compliance Cases.
